



Which Course Do you Plan to take?

There are three options to choose from as indicated by the arrows. Select the training that corresponds to your research area.

<u>Social & Behavioral Focus</u>: emphasizes human activities that are related to motivation, viewpoints, psychological process and interactions that may occur between persons, groups, the community and/or society in controlled or free-living situations. This work is often performed by academic disciplines including, but not limited to anthropology, economics, education, history, political science, psychology and theology.

<u>Biomedical Focus</u>: broad area of science that investigates how the human body works or how humans perform under and respond to controlled or free-living situations. Experimentation may be used to describe biological and physiological processes in human participants that occur under normal health conditions or in response to changes in their internal or external environment. This type of research may be used to identify biomarkers and risk factors that contribute to the development of acute illness and chronic diseases, as well as interventions to assess the safety and efficacy of structured interventions.

<u>Biomedical & Social & Behavioral Focus</u>: a combined training that covers each of the two focus areas
